



Karaoke For A Cause Competition Rules

1. Contest is open to Arkansas Residents only.
2. Must be 21 years of age or older to register.
3. No purchases necessary.
4. Contest will be held at Dugan's Pub, located at 401 East 3rd Street, Little Rock, Arkansas on Thursday, December 6th. Contest will begin promptly at 7pm.
5. There will be a total of 20 contestants. Contestant signup will begin at 6pm and will end at 7:30pm or until the 20 contestants are full. Duets are allowed.
6. Contestants will be judged in these areas:
 - a. Was the performance entertaining?
 - b. Did the singer draw in the crowd and you as a judge into the performance?
 - c. Was the singer enthusiastic about his/her performance?
7. Judges will include: Buzz on-air personalities, TV Hosts and one Youth Home representative.
8. In the first round, contestants will have a chance to sign one song. Song must be part of the Karaoke DJ's playlist. After all 20 contestants sing, judges will narrow the contestants down to the top 5. Those 5 contestants will take part in a second round. This time the contestant will sing to determine a 1st place winner. Contestants can change songs for second round if they'd like.
9. In an event of a tie, contestants must sing one more time with a completely different song then performed in the first and second round.
10. First place winner will receive a spot to perform in this year's Doublebee's Christmas Celebrity Karaoke Contest, Friday, December 14th, 7pm at the Arkansas Repertory Theatre. Winner must have song choice to sara@1037thebuzz.com no later than Monday, December 10th at noon. Contestant will receive one ticket for themselves, and one guest ticket to the event. Contestant must arrive no later than 6pm to the event. Tickets include free food, soft drinks, beer and wine.
11. The 4 runners up will receive a Buzz Prize Pack.
12. If contestants do not comply with these rules, the qualifier will be automatically disqualified from the competition.
13. One winner per household or immediate family.
14. Winner is eligible to play and win other games and contests on KABZ 103.7 The Buzz.
15. Employees and immediate families of KABZ 103.7 The Buzz, Signal Media of Arkansas and other media companies are not eligible to win.
16. Prizes are non-transferable.
17. Winners will receive their prizes directly after the competition held at Dugan's Pub.

18. All federal, state and local taxes, all licensing and title fees, insurance and all other expenses associated with ownership of the prize will be the responsibility of the winners. If applicable, a 1099 tax form will be issued to the winner and filed with the Internal Revenue service.

As a condition for receipt of the prize, if applicable, the winners must sign a document releasing KABZ 103.7 The Buzz, Signal Media of Arkansas from any all liability arising out of his or her receipt of the prizes and its ownership and use. Because the first prize is a performance at The Arkansas Repertory Theatre, winner is personally liable for anything arising from performing.
